The Master of Advanced Studies (MAS) in Transitional Justice, Human Rights and the Rule of Law (MTJ) is a one-year fulltime postgraduate degree designed for highly qualified and open-minded candidates interested in acquiring academic education and practice in this field. One of the very few programmes on this subject world-wide, its cross-disciplinary approach combines legal, political, historical, anthropological, philosophical and field perspectives and promotes both academic excellence and independent critical thinking.

Throughout the year, students have access to a prestigious faculty composed of leading academics and renowned experts and practitioners who are in touch with the latest developments and debates.

An ongoing focus on practice via exchanges with practitioners, work on concrete case scenarios, a study trip and clinical work allows students to develop the transferable skills necessary to succeed in the professional world and take up responsibilities in the field of transitional justice, human rights and the rule of law.
