

SHORT COURSE

THE RULES GOVERNING THE USE OF FORCE IN INTERNATIONAL LAW

ONLINE | 9-17 APRIL 2025



This short course provides an overview of the evolution of the rules governing the use of force in international law, focusing on military intervention on humanitarian grounds, the fight against international terrorism and the features as well as the shortcomings of the United Nations (UN) collective security system. It also addresses the concept of ‘Responsibility to Protect’ (R2P), as it has been developed by the UN General Assembly and put into effect by the UN Security Council and the members of the organization. It analyses both the positive and problematic dimensions of the developments concerning R2P, with particular reference to the situations in Libya and Syria. It finally discusses the theory allegedly permitting the use of unilateral force against states ‘unwilling and unable’ to prevent terrorist activities within their territories.
